- **Bank Statements – Submit full copies of the last two months statements for all banks and investment accounts.**
- **Divorced applicant or Applicant receiving Child Support – Provide a complete copy of the Divorce Decree, Property Settlement and/or Child Custody/Support paperwork, if applicable.**
